All customers approved for credit accounts are bound by the following General Credit Terms and Conditions.

1. Terms for Non-Project/Contractual sales are Net 30 Days. Paid When Paid will not be accepted. Future shipments will be withheld, and your account will be placed on HOLD when overdue balance exceeds 45 days. This will apply to the entire account and not be dealt with per order/project.
2. Accounts not paid by the due date are subject to interest charges from the date of maturity at the rate of **1.5% per month (18% per annum)** as shown on invoices/statements.
3. All invoices with a **Project/Contractual Purchase order** will fall under the Prompt Payment Act with terms of Net 7 days from receipt of payment by the owner. Invoices must be paid in full net of ten percent (10%) pursuant to the Construction Lien Act 1990. Unauthorized deductions and/or returns will not be accepted. Changes or adjustments to credit terms must be agreed to in writing by Pro-Able.
4. All claims against products received must be made within **5 Business Days** after receipt of goods.
5. An order will **NOT** be processed until your Purchase Order, Contract or Written Authorization to Proceed is received.
6. On shipments made by common carrier consigned to the customer, all claims for damages in transit must be signed for as such and Pro-Able informed as soon as possible.
7. Pro-Able is not responsible for unloading, storage or protection of material at jobsite.
8. Product and/or Services (labour) will be billed proportionately as shipped/supplied.
9. Goods/Merchandise must be authorized for return by Pro-Able and will be subject to a **Minimum 25% restocking charge**. Non-stock product is subject to a Pro-Able restocking charge, the suppliers restocking charge and any related material handling costs. Non-stock product that cannot be returned to the supplier is not returnable. Product is not returnable if it is not complete, in original condition/packaging.
10. **Under no condition will a Back Charge be accepted for any reason unless it is approved prior to it being performed. Approvals for any type of Back Charge must be agreed to in writing BEFORE proceeding.**
11. **Non-Sufficient Funds (N.S.F.) cheques will be subject to a \$100.00 charge.**
12. The customer agrees to promptly notify Pro-Able of any changes in the customers business name, address, or chief place of business.
13. Current credit information may be requested to retain credit account status.
14. Pro-Able shall not be liable for any delay in delivery or for non-delivery, in whole or in part, caused by the occurrence of any contingency beyond the control of either Pro-Able or Pro-Ables suppliers. While every reasonable effort shall be made by Pro-Able to adhere to proposed delivery dates, all shipping dates are approximate only.
15. Should the customer default in payment of its outstanding account, or should a default be declared, then Pro-Able shall be entitled to incur expenses and/or the cost of collection and this amount shall be added to the unpaid balance of the customer's account and shall be due and owing from the customer to Pro-Able.
16. The failure of Pro-Able to enforce any right or remedy against a customer or the acceptance by Pro-Able of any partial or late payment from a customer shall not be deemed to change the General Credit Terms and Conditions.
17. This agreement binds the customer and Pro-Able and their respective successors, personal representatives and assigns.
18. This agreement is governed by the laws of Ontario.
19. It is the express wish of the parties that this agreement and any related documents be drawn up and executed in English.
20. Failure to comply with these terms and conditions may result in cancellation of credit privileges without notice.
